1. Eligibility

Applications are accepted from now until May 24, 2024. The content, form, and media of the works are not limited. Anyone regardless of age, regardless of nationality, who currently have no gallery contract are welcome to apply, and no participation fee is required. 3、 Rules/ Mechanics

- (1) Registration method: all online registration, please go to (<u>Google Forms</u>) for online registration.
- (2) Application Information
 - 1. Personal information (including filling in basic information, communication methods, education background, exhibition experience, award-winning records, etc.).
 - 2. Work information includes title, medium, size, year of creation and concept of creation. <u>Please upload 3-5 works</u>。
 - 3. After uploading the materials and completing the registration process, no

data changes will be accepted.

(3) File Formats

The files of the uploaded works will be used for the design and publicity of this event. In order to ensure the quality of submissions and event promotion, please upload them in the following file format:

- 1. **Flat Surface**: Upload one picture for each work, the file format is limited to JPG files above 2MB and below 10MB, and the resolution is 300dpi
- Three-dimensional: For each work, upload one main picture and at most three partial pictures from different angles. The file format is limited to JPG files of more than 2MB and less than 10MB, with a resolution of 300dpi.
- **3. Video**: Digital video, the maximum length of the work is 5 minutes, and the file format is limited to MP4 files, under 100MB.
- 4. Installation: One main picture and at most three partial pictures from different angles in the space for each work. The file limit is a JPG file of more than 2MB and less than 10MB, with a resolution of 300dpi. If there are digital audio-visual files, the length should be no more than 3 minutes, and the total should be less than 100MB; the format of video files should be limited to MP4 files, and the format of audio files should be limited to MP3 files.

4. Application Time/ Notification

- (1) From April 26 to 5:30 pm on May 24, 2024.
- (2) Those who apply must complete the uploading of all materials before the deadline of application. <u>If the uploading of materials is not completed</u> <u>before the deadline, the application will be considered unsuccessful.</u>
- (3) The results of the selected artist will be announced on the gallery website, and they will be notified by phone before June 1. Those who are not selected will not be notified separately.

5. Review method/ Reservation

(1) The applications will be reviewed according to the submitted information,

and will be reviewed by the professional team of the gallery,

(2) The gallery reserves the right to give reservation in incase initial candidates are not able to participate .

6. Exhibition Details

- (1) Selected artworks will be exhibited from June 14 (Fri) to July 6, 2024(Sat) in the gallery. The gallery reserves the right to allocate the exhibition venue. If the selected artist are unable to cooperate with the exhibition for some reason, they will be deemed to have waived their rights automatically, and their qualifications will be replaced by reserve artists.
- (2) The selected artist must submit the final information of the exhibited works within 7 days after the gallery announces the list of selected artists (such as artwork files, materials, resumes, work concepts, list of works and prices, etc.)
- (3) The selected artists (excluding foreign artists) should install their work for the exhibition before the opening, and dismantle the exhibition after the end of the exhibition period. The transportation and accommodation during the installation and dismantling shall be borne by the selected artists.
- (4) The selected artworks will be displayed for sale in this exhibition, and the pricing of the artworks will be filled in the list of artworks.
- (5) In case of sale of artwork, <u>50%</u> of the list price belongs to the gallery ,<u>50%</u> of the list price belongs to the artist.
- (6) The gallery has the right to lead all business transactions during the exhibition period, and the responsibility to maintain the safety of the artworks during the exhibition period, but the gallery shall not be liable for compensation in case of damage caused by natural disasters that cannot be stopped by human effort (such as earthquakes, floods, fires...).
- (7) Artist must declare that his/her application to the open call is his/ her original work, and must also declare that his/ her application does not infringe any 3rd party's copyright. Any situation that may arise pertaining to copyright infringement will be on the accountability of the artist. Gallery reserves the right to disqualify at any time in case there is an infringement.
